## Comments

The pregnant client who was a resident at the shelter went into hospital to give birth (a boy) and then returned to the shelter. The counselor was happy that H&S was instrumental in helping the woman who was in dire need.

A client of H&S visited Transitional House for assistance.

Clients were referred to other organisations for assistance.

Three children were removed from violent homes after the intervention of the counselor at The Transitional House and the Child Care and Protection Agency.

## Comments

One counselor indicated that the violent and aggressive behavior of some of the children seen was due to a lack of parenting, most of them being single parents with absent fathers, and also teachers who did not take appropriate action with regard to the children's behavior.

Another counselor had to call in the Child Care and Protection Agency to intervene in the case of a female student who was not attending school and was experiencing physical abuse in the home after her grandmother had kept her at home to take care of a cousin. The child was removed to a safe environment and was able to return to school.

## **Children's Group Sessions**

## Topics Discussed:

- Self Esteem (a film on Self Esteem Building was shown)
- Positive Attitude
- Anger Management
- Changing Violent Behavior
- Communication

#### Comments

The sessions were successful with the students participating and asking questions such as: "if your teacher is violent to you what should you do?" The children complained that the teacher called them names and told them they would turn out to be nothing in life.

The counselor discussed the importance of having a positive attitude and told them about how it can help with their situations.

The children did two role plays of events that happen in school and how they should deal with them, along with new information and skills on how to deal with other situations. They also took part in a skit displaying effective communication.

## Evaluation of the sessions

Questions and discussions took place with regard to the most troubled children.

Several teachers in discussion with the counselor expressed mixed feelings about an incident of violence involving students. The head teacher mentioned that most of the time

is spent disciplining the students, and this was observed by the counselor during the time she spent at the school.

The counselor reported that the teachers expressed the view that the rod should be used in schools and that most parents agreed that teachers should beat students in school whenever the need arises. The teachers felt that most of the students who behave in a delinquent manner live below the poverty line.

The teachers were very interactive and asked questions on the topics discussed. Handouts and a booklet on the Universal Declaration of Human Rights were given to each teacher and discussed. All the teachers said that it was the first time that they had received such material and expressed appreciation for it.

## Observations

The counselor observed that teachers spent most of their time in the staff room during school hours setting work for the students, who were then left in the classroom to do their work.

On one visit, the teachers were seen in the staff room during class period.

All the teachers attended at least one session, including the deputy head, who attended the last session.
