Other

Institutional Capacity Building

Capacity building was conducted with FACT and Comforting Hearts, two NGO's working in the area of HIV/AIDS in Region 6. Information received was that the field staff from both organizations were meeting with people who are experiencing DV in the homes and the communities they work in.

One three days and one two days workshop were conducted with each of the organizations using presentations on topics including Self; Gender-Based Violence; Child Abuse/Child Sexual Abuse; Alcohol Drug Abuse, Anger Management; How to deal with the male Perpetrator; Trafficking in Persons etc. The methodology used was interactive with discussion and group work including skits on topic areas and power point presentations. The evaluation on the workshop showed that for the first time most participants were exposed to the topics presented. Certificates of participation are to be presented to the organization and to the participants who were in attendance. These activities were funded by the Canadian High Commission through the Caribbean Gender Equality Project.

1. B. Project Management:

Monthly meetings will be held with project staff to discuss the smooth implementation of project activities, while the regular fortnightly planning meeting will also be conducted for all staff working under other projects. Monthly reports both narrative and financial are prepared and sent to the members of board of directors for the purpose of their scheduled monthly meetings.
